

All state chapters are requested to keep in touch with all NCCOEEE constituents in the respective states to ensure united action / demonstration / protest at the event of any exigency / atrocity on the struggling Electricity Workers, Employees and Engineers. As the Central Govt. has disregarded the concern and agony of Electricity Employees and Engineers conveyed on a number of occasions, National Co-ordination Committee of Electricity Employees and Engineers (NCCOEEE), a broad based platform of all major National Federations of Electricity Employees & Engineers organized a National Convention at New Delhi on 8th June, 2018 to decide an action plan to oppose Electricity (Amendment) Bill, 2014. The Convention decided to resort to one day's nationwide strike / Work Boycott on 7th December, 2018 to press the demands of Electricity Consumers, Employees and Engineers. A copy of the Declaration adopted in the Convention, duly signed by the leaders of the NCCOEEE constituents was sent for your contemplation.

We have noted with serious dismay that the Central Government has floated an Electricity (Amendment) Act, 2018 on 7th September, 2018 seeking public comments within 45 days. As we have become familiar with your policy of evading consultation with representatives of National Federations of Electricity Employees & Engineers unlike your predecessor, NCCOEEE constituents submitted view points on the draconian anti-people electricity legislation with clear object of snatching away right of access to electricity from majority of Indian people in the interest of ease of making business for the profit monger community.

On 28th September, 2018 all National level Trade Unions and Federations organized a Convention at Delhi and resolved to call 2 days Nationwide Strike on 8th and 9th January, 2019 to press 12 point Charter of Demand for all walks of life. Leaders of NCCOEEE National Chapter met at Delhi on 29th September, 2018 and decided to support the demands and call for two days' strike / work boycott on 8th and 9th January, 2019. Besides 12 point demands, we press your Government to settle the issues attached hereto.

- 1) Stop further action on anti-people legislation and withdraw Electricity (Amendment) Bill, 2018.
- 2) Integrate all unbundled SEBs in Company Structure like KSEB Ltd / HPSEB Ltd.
- 3) Natural energy resources should not be transferred to private hands.
- 4) Ensure Equal Wage for Equal Work pending regularisation of all Contract / Casual / Outsourced / Franchisee Workers in regular jobs like Telengana Govt.
- 5) New Pension Scheme will have to be abolished in Electricity industry and all are to be covered in pre- 2004 Pension Scheme / pre- unbundling pension Scheme, where unbundling took place before 2004.




